- B** All materials/ancillary products that are not shipped inside modular building sections are subject to additional freight charges that will be calculated at time of proposal.
- C** Fees for crane, rigging and other equipment to assist in placement of buildings and material handling (if required) will be according to RS Means
- D** For items listed as "Open Market", pricing may be determined by RS Means or by obtaining at least two proposals in the open market for the desired goods or services plus mark up
- E** Pre-engineered metal building (Item 29) includes: building; foundation; slab; HVAC; doors; electrical
- F** Minimum order quantities apply for prefabricated ramp, stair and platform systems and aluminum canopy systems
- G** Additional buildings, ancillary products/services and additive offerings are also offered on a per square foot, linear foot or cubic foot basis.
If the desired building or ancillary product/service size, use, configuration or specification is not listed exactly on this proposal, it may be priced using the listed price of the item closest to the desired item. In order to do so, the cost per square foot, linear foot or cubic foot is to be calculated and applied to the overall size of the unspecified item to arrive at the offering price.
- H** General requirements are calculated at 5% - 10% of the total order and added to the stated pricing
- I** For a standard specification building:
 - Apply a discount of 35% to any building listed in Section II Items 12-24
 - A 25% discount to any building listed in section III, Items 31-40
 - A 15% discount to Section III Item 30
