Re: Response Cover Letter to Florida Buy RFP 21-15 Modular & Pre-Engineered Buildings

Thank you for the opportunity to present our solutions to PAEC and its current and future member customers. We have read through and understand the RFP documents.

The enclosed offering is multi-faceted and includes a Narrative, required Bid Forms, Supplemental Pricing Catalogue, Specifications, sample Stock Floor Plans with Elevations, Clarifications, and supplemental promotional and marketing collateral. Available offerings are illustrated in this proposal along with additional modular and pre-engineered buildings that can be derived through the mechanics stated in the pricing catalogue and supplemented by using RS Means.

It is important to note that Fabricon's pricing is based on new equipment. The CL designated models are built to specifications that exceed minimum standards. The base classroom model (CL2436) is of type II-B non-combustible, steel framed construction. The building carries a 1-hour exterior fire rated wall assembly. Through the upgraded specifications, use of the base CL2436 offers maximum versatility. For instance – buildings can be placed lower to the ground, side by side or end to end, on permanent foundations, resulting in less cost for ramps, steps, skirting and site utilities as well as less space consumed on campus.

We understand not all budgets can support the upgraded specification, so we have also included line items for standard type V-B, wood framed constructed classroom buildings.

Office buildings vary from models using the upgraded FM specifications to industry standard SM models. The FM spec does offer high end components such as perimeter main frame and double layered sub-floor. In addition, our unique steel rigid-frame buildings are listed for various models.

The Fabricon in-house project staff has completed both single level and two-story projects covering a variety of work scopes. Evidencing a focus on safety, our record as measured by our EMR has consistently trended downward over the last three years from 1.00 to its current .84 as calculated by NCCI. Superintendents are trained in first aid and CPR and hold OSHA 30 certifications. We only contract with a pool of licensed and insured subcontractors who understand the high-performance levels required by Fabricon and its customers.

We are excited to be considered for award by PAEC and we are prepared to execute to the highest level of integrity, efficiency, and professionalism. We trust this RFP response will enable your team to move forward with Fabricon as an awardee.

Section 2. Narrative

Fabricon Role in Florida Buy Partnership

Fabricon Modular envisions its role in the partnership with Florida Buy State Cooperative Purchasing as one of facilitator. Our goals include accurately and effectively presenting the partnership to all eligible entities. The in-depth nature of our response helps demonstrate our commitment to make available a wide range of products and services to all co-op members at competitive market rates. The Fabricon RFP response is structured in such a way to be versatile and thus adaptable to virtually any customer need. All customers are guided by a knowledgeable Fabricon representative during the identifying, qualifying, configuring, procuring, and delivering process. The ease of doing business with our partnership will result in increased in business volume through satisfied customers. The partnership businesses will grow not only through referrals but also through the marketing and training outline listed later in this Narrative.

Fabricon Modular Overview

Fabricon provides prefabricated and modular space for a variety of industries. As a full-service provider incorporating the expertise of a nationwide network of designers, fabricators, suppliers and manufacturers - Fabricon guides projects through design, planning, permitting, manufacturing and installation, nationwide. By leveraging resources, customers achieve economies of scale and uniformity of process while growing their enterprise.

Choose from standard floor plan options or customize a complete building system for more unique requirements. Fabricon always remains focused on timely, cost-effective, and choice products to rival the aesthetics and performance of traditional construction methods.

In addition to its core modular design, sales, and installation business, Fabricon leases and finances modular buildings, including providing post construction ongoing facility management and maintenance solutions. Headquartered in Jacksonville, Florida, Fabricon employees have an on-the-ground presence across Florida and Georgia through a network of three branch locations.

Fabricon has the capability of, and typically chooses to self-perform work for which it is appropriately licensed and qualified. Per state licensing and manufacturing requirements, all specialty and trade work is subcontracted through appropriately licensed and qualified subcontractors including, but not limited to, mechanical, electrical, plumbing, gas, and roofing. The ability to complete work in-house provides advantages to control quality, budgets, and schedule on our projects. All staff are legally authorized to work within the United States and pass background and drug screenings as a condition of employment. Construction staff minimally possess industry OSHA 10 safety certifications and first line supervisors (General Foreman/Superintendents) earning industry OSHA 30 certifications.

Prequalified subcontracted trades possess the ability to travel and national or regional suppliers with whom existing relations are established provide the ability to service the state as needed. When available, beneficial or required, the use of local business is sought. Similarly, Fabricon has professional resources including construction law firms and real estate law firms who also service a broad geography. These professional service firms typically have presence in major metropolitan areas providing added value for local matters.



As a customer, you receive accurate project pricing early and often while our representatives foster your understanding of the process. The efforts of the team deliver consistent expectations, deliverables and performance. On a macro level, building designs, components and services are procured using the same processes. Our design partners understand modular construction and the inherent nuances it brings versus conventional construction. Engaging a “modular friendly” architect is critical to the success of the project. Designing modular from the start saves time and money. In addition, understanding state by state requirements for modular buildings and dealing with local officials as it pertains to design and permit of commercial modular buildings is a specialty skill set. This is also true for manufacturing. Our partners in manufacturing operate locations in several states across the sunbelt. Total manufacturing capacity is approximately 4 million square feet per week. Fabricon Modular, a BHRS Company (the “Company”), was founded in 2014 and has been in continuous operation since founding. Through complimentary but separate business operations, BHRS provides comprehensive modular manufacturing, construction management and contracting services, and commercial realty services to businesses, managers, tenants, investors and organizations alike primarily throughout the southeast United States with select export service to international customers abroad. A diversified business approach and multiple revenue streams reduce volatility to any one particular market segment and supports the Company’s long-term growth model.

Customer Support and Philosophy

Fabricon excels at identifying and fulfilling optimal modular solutions for customers. Through consultative exchanges, projects are developed and supported by effective relationship building and communication. Our recommendations to customers always include sound building practices, use of top-quality materials and knowledgeable guidance on codes and general construction. Our most successful projects follow this model and allow us to properly handle simple to complex projects.

We utilize a construction-based software (one program platform) that incorporates accounting, construction administration, submittal correspondence, drawing indexing, and procurement - all in conformance with CSI formatting of the project.

Our principal staff includes extensive experience in various disciplines: sales/consulting (75+ years), finance (50+ years), project management and field supervision (50+ years), service and administrative functions (15+ years). All staff members are involved in customer assistance for proper project development and execution.

The appropriately qualified representative within our organization will provide guidance and/or assistance using institutional knowledge of modular construction to the cooperative member and/or the member's design professional. The goal is for the required designs to be completed correctly, efficiently and at the lowest possible cost. Our representative will be available to review documents and answer questions.

The following can be performed by in-house qualified Fabricon personnel: project estimating, pre-construction services; project management; project administration (including AIA documents, Schedules of Values, lien waivers and the like), project site supervision, site safety requirements, oversight and reporting,



repair estimates and service to building structure, systems and finishes, delivery and installation of miscellaneous materials.

Fabricon assigns an executive manager of the firm to each of its projects to assure quality consistency as well as to provide the guidance and oversight. The executive manager oversees all facets of the project from development to close-out and serves as a “go-to” strategy in the event a customer becomes dissatisfied with a particular portion of the process of order fulfillment and completion.

Obtaining Service

Fabricon maintains its own fleet of company service vehicles fully stocked with parts and supplies. In the event of a service call, the customer will contact the designated representative within Fabricon to discuss the issue. If Fabricon is to perform the work, a Work Order Authorization or Work Order Agreement (the Document) will be completed, and the work scheduled. Upon completion of the work, both the authorized customer representative and Fabricon field representative will be responsible for reviewing the completed work and signing the Document to close out the service call.

The customer may request Fabricon complete work that is neither a covered service call, nor warranty claim. In such a case - cost structure for the work will be discussed prior to a site visit or work occurring. The cost for the work will in part depend on the degree of information available at time of customer “call-in,” the nature of the work, and current resource allocation. In some cases, an agreement may be made to perform the work on a time and materials basis.

The time frame for completion of service requests is taken seriously. 1-Critical/Emergency requests that involve system failure or safety hazard that effects a portion of a building with a potential to shut down the building or cause physical danger to members of the staff or others, or the inability to properly secure the facility, have an immediate response with work ongoing until condition is stable and/or complete. 2-Urgent matters, ones that immediately poses a threat to health and safety and affects the facilities’ operations and ability to service its members, are responded to within 24 hours. Other priorities including, 3-Normal and beyond, or ones that address issues creating a minor inconvenience for the building or working environment but do not pose a threat to life, health, or safety (i.e., miscellaneous maintenance/repairs), are to be responded within 72 hours for scheduled completion in agreement with the requestor. Non-emergent/urgent, or Standard requests are typically completed within two weeks from the request date.

Marketing and Training Outline

In addition to our sales team's daily individual efforts to continuously promote the contract and create exposure on every opportunity encountered, we have on staff a full-time marketing professional to coordinate widespread efforts across product offerings and geographical regions.

Companywide, Fabricon utilizes a top-rated CRM for the flow and management of all customer related data. We have designated a Co-Op category within the CRM. Therefore, each opportunity, contact or account will be identified as “Co-Op based.” This facilitates not only achievement of the active sales and marketing plan but also the ability to study information via the analytics function built into the system. This reveals valuable information on buyer habits and allows Fabricon to focus its future sales and marketing efforts in those areas that have proven to be the most effective.



Upon contract award, an initial press release will be crafted and distributed to select media relations and services. Postings will be made on various social media platforms. The Fabricon website will be updated with the award notification and the FL Buy logo prominently displayed. Our current customer database will receive separate notification via our capability to mass market through our CRM.

Each current customer entity within the Co-Op will receive a personal phone call and/or visit from a sales representative to "announce" the award and highlight the benefits of doing business with the partnership. Follow up contact will be made to ensure all requests for more information are fulfilled.

In addition, as part of on-going efforts, email drip campaigns will be instituted at internal and external levels. It is anticipated each drip campaign will occur once per month promoting: the ease of doing business for Co-Op members, knowledgeable guidance, detailed project support, fast delivery of stock buildings and enhancement products and services.

Press releases, social media postings and highlights on the Fabricon website will announce all new awards stemming from use of the contract.

Dedicated marketing literature and including presentation will be created focusing on the Co-Op, the award, and its availability for use. This information will be used on sales calls, at trade shows and appropriately disseminated to all contacts established in our daily sales efforts.

Training will be conducted with the applicable sales and administrative members of the Fabricon staff. Content will include at a minimum: review of the contract and how to "sell" it, proper procedures for pricing, accounting, accounts payable, record keeping, and auditing.

To leverage the partnership, Fabricon marketing/sales will engage with the Co-Op's marketing/sales to brainstorm and implement joint sales and marketing efforts for both initial award and on-going efforts. Fabricon has all sales and marketing plans will be reviewed.

Overview of Project Approach

Procedure for Ordering Goods and Services

Fabricon approaches every project with a uniform focus on defining the solution, delegating responsibilities, follow-up on task completion, and consistent communication. Fabricon's responsibilities shall include coordination assistance and interaction of the combined team efforts to properly develop and complete the proposed project. This includes, but is not limited to, proper agreement execution and completion of Fabricon's defined scope of work. The scope of work at a minimum shall encompass proper design approval, specification development, manufacturing/construction of the modular equipment, project scheduling, shipping from origin to destination, delivery functions at the project site, structural blocking and foundations, leveling and anchoring, completion of any finishes at the mate lines, and a final walk through of the modular building/equipment for identification and completion of any final punch list items.

Fabricon will assist in development of these initiatives through interaction among its own team members, the designer of record, its manufacturing partner (if applicable), and any subcontractors. The most cost-effectively designed modular building solution will be derived from the interaction between the parties.



Cost control and compliance to specifications will be monitored through communication with the customer. An active RFI (Request for Information) log will be used for identification of issues, submission of questions, documentation of answers, and closure of open items that may present throughout performance of the project. Strict scopes of work for the subcontractors will be developed and monitored for proper compliance with the agreement's documents. Opportunities for incorporating value engineered solutions will be incorporated into project for discussion and consideration by the member customer.

The appropriate form of agreement will be selected for the scope of work of the project. The contract will be populated with applicable exhibits and the package labeled Contract Documents. Building and construction projects by nature can be very complex. Due to the varied nature of building construction, site conditions, and occupancy requirements, it is anticipated various exhibits will be applicable for each order. For instance, a typical Contract Document package may include: the agreement, drawings, scope of work, specifications, a schedule, and any additional clarifications or addenda relevant to the project. It has been determined over several years and countless projects that this type of package equitably suits and offers protection to both parties in the contractual relationship.

Design and Development Phase

After receipt of the order and execution of the agreement, review of the specifications and proposed layouts by the customer, Fabricon will order the first round of shop drawings. Throughout the drawing process, Fabricon will monitor the drafts for compliance with the design intent. Written clarification may be requested from the customer concerning any questions and/or potential conflicts. To aid in quality assurance, material submittals will be forwarded to the customer for review and approval prior to procuring the respective components. Prior to completion of the shop drawings, a concerted effort for options analysis and value engineering will occur. The customer will have the opportunity to provide feedback and present questions around cost versus benefits for any material and/or design changes prior to production commencement.

Agreed upon changes shall be incorporated into the shop drawings for any revisions. Fabricon will then meet with the customer to perform a final shop drawing and specification review. Upon customer approval the shop drawings will receive final architectural and engineering approvals through a third-party agency. Throughout the drawing process Fabricon will communicate any cost or schedule impacts to the customer via written correspondence. Written approval from the customer will be required for all cost or schedule changes via a written change order. All required shop drawings will be signed and sealed by the appropriate design professional before final submission to the Customer and production.

Order and Construction Phase

After completion of the shop drawings, the modular building/equipment order will be released for production and local permitting will begin. The customer will regularly be informed by Fabricon of the progress against the preestablished production schedule. The schedule will be regularly updated, especially as milestones are achieved.

Quality control inspections will occur at the manufacturing facility during production. Quality control inspectors will audit the buildings against the plans and issue approval or modification notices to the



manufacturer. The customer representatives are encouraged to visit the manufacturing facility at any time during the process.

Logistical Phase

After the local building permit is issued, Fabricon will schedule with the required subcontractors to complete the foundation, transport, stage, install the modular building/equipment, and complete the work in accordance with the approved shop drawings and agreed scope of work. The Fabricon site supervisor will be responsible for coordinating the proper sequence of events on site while maintaining communication with the customer designated contact regarding on going activities and schedules. Each shipment to the site will be checked and inventoried prior to leaving the factory.

During delivery and installation phasing, site safety for all personnel is important. Fabricon's and the customer's safety policies and rules will be distributed to all Fabricon employees and subcontractors, and activities monitored for compliance.

Completion of skilled trade work on site will be accomplished with Fabricon and subcontractor personnel. At time of Substantial Completion, Fabricon will make available a qualified representative to perform a walk-through of the building. A punch list will be developed and distributed to all relevant parties. The punch list will include the responsible party's task(s) to be performed before final completion, and the expected deadline date for completion. At completion of the punch list, the customer will be notified and the project considered closed.

Time Frame, Scheduling and Project Controls for Order and Receipt of Buildings and Equipment

The modular industry can experience seasonal fluctuations in demand for goods and services. It is imperative sufficient scheduling and controls are integrated and maintained as standard operating procedures. Fabricon project scheduling is done using current construction specific software and estimating programs. Using this integrated software, Fabricon can have the information created and uploaded as a data base for the project schedule. This means all the man-hours and crew sizes are recognized by the software thus allowing the schedule to reflect the actual concept of the project as estimated. Once this data is introduced to the scheduling department, this information is analyzed and factors such as human resources, material sources and the customer's requirements are accommodated.

Project controls are handled technology using networked computers, devices and mobile apps for construction specific software and CSI formatted job costing. Both management and field supervisory personnel use this software to enter and withdraw data relative to each project. Some of the advantages of this process are as follows:

- The reporting of daily activities is done within a given format thus ensuring the data is uniformed and recognizable.
- The availability of accessing the database for your project and coordinating that with Fabricon field personnel ensures that both are viewing and describing the same information in real time.
- Documenting and organizing of project files including RFIs, submittals, change order/directives and reporting logs are conveniently tracked in one centralized location for easy retrieval.



More important than the technology and individual capabilities of each team member is the basis of communication between Fabricon Modular and the member customer. The ability to analyze data, provide timely responses and react to changing situations is greatly enhanced by the methods that are employed by Fabricon. This system gives management the complete understanding of the status of the project and allows them to react to any and all changing conditions.

An average time frame for delivery of our new modular buildings/equipment after receipt of order is approximately 8-12 weeks.

Subcontracting Plan

Fabricon understands that adherence to strict quality standards is the basis of all successful building projects. Subcontractors often are responsible for completing specially skilled portions of work associated with a project.

To ensure the highest standards of performance and professionalism are achieved for our customers, Fabricon has developed and maintains the following vendor processes:

- Evidence of sufficient insurance and safety record as determined by Fabricon
- Evidence of sufficient experience in their respective field
- Review and acknowledgement of the BHRS Companies Safety Manual
- Execution of a project specific Fabricon Purchase Order or Subcontractor Agreement
- Demonstration of general knowledge of drawings, specifications, scopes of work, and schedules
- Documentation of available equipment and human resources for the specific project
- Understanding of Fabricon's written solicitation with requested delineated work
- Written responses adhering to the solicitation
- Adherence to all instruction by the Fabricon field supervisor
- Completion of site logs
- Completion of administered contract documents
- Certified payroll (if required)

Quality Control and Safety

Fabricon has a team approach for all its projects. In the interest of continuity, construction project teams are maintained intact from start through close out. This strategy assures availability of knowledgeable staff that promotes the fulfillment of design intent and facilitates the construction process.

Construction quality control and coordination strategies have been tailored to follow those used in accordance with standard industry practices for construction bid situations with respect to shop drawings, inspections and permit approvals are concerned.

Quality control inspections occur during production and prior to shipment of all new buildings. Fabricon maintains a full Quality Control manual and Safety Manual. Both manuals are updated periodically and available for review upon request.

Proposal Clarifications

The following Clarifications are applicable to this proposal and shall be incorporated herein by reference. Unless specifically itemized on Fabricon's Quotation or Lease Order Agreement, and explicitly stated on the project's Scope of Work it is assumed the Scope Clarifications items are to be provided by Others and are excluded. **IF NO PROJECT SPECIFIC SCOPE OF WORK HAS BEEN PROVIDED, THEN FABRICON'S STANDARD – SCOPE OF WORK (R3.21) APPLIES.** Some, all, or none of the following Clarifications may be applicable to specific orders or contracted projects as agreed between Fabricon and the Customer.

The term "Others" denotes not by Fabricon Modular ("Fabricon"), or its agents, employees, or subcontractors. The term Buyer/Lessee ("Customer") refers to the entity contracting directly with Fabricon.

Site Conditions and Preparations Scope Clarifications

1. Excavation is assumed and included only for non-compacted soil (surface and subsurface) to anchor or install footings. Excavated fill remains at point of excavation. All other surface and subsurface materials, including movement and transportation or storage of excavated fill, will be considered extra work and may be provided for an additional cost.
2. A secure staging area available for use located adjacent to the work site with unrestricted access to Fabricon is assumed to be provided Customer.
3. The following items (if required) are assumed to be provided and completed by Others: site plans, site/environmental permits, site preparation (including but not limited to) impact fees, engineering fees, soils reports, scraping of surface vegetation, compacting of site to ≥ 2500 Pounds Per Square Foot (PSF) and leveling grade $+- 3"$ extending 3' beyond the proposed building envelope, identification or remediation of hazardous materials from soil, for placement of footings or access to site/building pad, dewatering, marking of all underground obstructions, storm water management erosion and sedimentation control, proper grading of site to allow for positive drainage away from the building, suitable and acceptable access for the modules by standard truck onto the building pad, site clear of all other trade's until such a time that the modular building is in place.
4. Multiple drops will be provided under the building for potable water and waste piping, and electrical conduits. Site utility extensions and connections (including piping, wiring, and devices) to these drops are by Others.
5. Customer to ensure appropriate potable water, fire water, and sewer line sizes and pressures exist on site prior to connection to the modular building or equipment.
6. Building water supply piping is CPVC. Waste piping is PVC. Heat tracing/insulation of exposed potable water/sanitary sewer piping is by Others.
7. Appropriate on-site dumpsters and waste receptacles provided for Fabricon's use, if needed, are assumed to be provided Customer.
8. Fabricon shall be granted the option to place signage on-site for displaying and advertising company information until completion of the project.



General Building and Equipment Scope Clarifications

1. All keyed cylinders assumed to be unique per lockset. Final master keying of keyed cylinders to be alike may be provided by Fabricon for an additional cost.
2. Surface affixed metal seam strip provided on all flooring seams at mate lines between modules assumed and included within provided Supplemental Pricing Catalogue. Additional finish options may be provided by Fabricon for an additional cost.
3. All low voltage systems, including but not limited to: fire alarm, data/communications, security, controlled access, and audio/visual shall consist of empty J-boxes and empty conduit stubbed either below floor or to attic. All equipment, devices, wiring, and testing is provided by Customer.
4. All life-safety requirements including fire extinguishers, fire alarm, and fire sprinkler (including painting of piping, testing, certification) are provided by Customer.
5. All structured cabling including overhead conduits and cable trays are provided by Customer.
6. Lightning protection and/or surge suppression is provided by Customer.
7. HVAC test and balance, including any required reports or certifications, are provided by Customer.
8. Color selections, building components and finishes are Fabricon standard unless specifically noted otherwise.
9. All ramps, steps, handrails, and ancillary components shall be constructed of prefab aluminum or steel per pre-engineered and stock configurations. Stock, non-stock and site-specific sealed drawings may be provided by Fabricon for an additional cost.
10. All setup and foundation assemblies shall be comprised of single thickness, dry stack, hollow core, CMU block piers with ABS base pads on existing grade with maximum pier height of 24". Tie down anchoring shall be accomplished with single helix 48" anchors and strapping affixed by split bolt unless specifically noted otherwise.
11. Hitches, wheels and axles will remain on modules. Removal of hitches, wheels and/or axles for on-site storage and retention by Customer may be provided by Fabricon for an additional cost.
12. Skirting, if proposed, is vented white vinyl supported by pressure treated framing unless specifically quoted or noted otherwise.
13. Storm shutters, impact glass and/or protection of all openings is provided by Customer.
14. Crawl space under modular building shall not be classified as a "confined space."
15. Building, foundation, anchorage, ramps and steps will be designed and constructed to comply with the latest revisions of International Building Code 2021, or Florida Building Code 2020 (7th Ed.) as it applies to the Modular Buildings Program (or equivalent governing agency) for the particular state in which the project is being completed. Any additional requirements by local inspectors and/or other agencies, including governmental, are the responsibility of the Customer.
16. Customer agrees to not occupy, have access to, or possess keys to the building(s) prior to execution of Fabricon's *Substantial Completion and Beneficial Occupancy* form as mutually agreed to by Fabricon.
17. In the event of occupancy or early access by the Customer prior to Substantial Completion and Beneficial Occupancy, Customer agrees to be held responsible for all liability associated with injury, death and/or property damage.



Quotation and Agreement Clarifications

1. The Customer agrees to obtain and pay for general contracting services, including providing and paying for all necessary permits, fees, licenses and Certificate(s) of Occupancy.
2. Permits and fees for delivery or return transportation of building modules and equipment to/from site shall be provided by Fabricon.
3. The Customer agrees to execute Fabricon's *Sales Agreement, Work Order Agreement, or Lease Agreement* as the governing document ("Agreement") for any proposed transaction which references the provided *Quotation*.
4. The Fabricon proposal, in its entirety, shall be included and made a part of any Agreement resulting from this proposal. In the event of conflict, the contents of the proposal and Agreement shall be considered binding between the parties and supersede all other documents.
5. Credit review and approval to be completed in accordance with Fabricon corporate standards and underwriting guidelines. Payment terms and draw schedules are to be based on these standards at the sole discretion of Fabricon.
6. Schedule for final completion shall be negotiated between Fabricon and the Customer at time of event.
7. Fabricon shall furnish its standard certificates of insurance evidencing statutory Workers' Compensation, General Liability coverage of \$1,000,000 per occurrence, \$2,000,000 aggregate per policy, and Auto Liability with combined single limits of \$2,000,000, to be effective while Fabricon is working on the project site. The Customer only shall be named on the certificate as additional insureds with respect to liability coverage only. Fabricon's insurance is primary with respect to its scope of work only. Waivers of Subrogation and copies of policies shall not be provided. Special endorsements may be provided by Fabricon for an additional cost. Any subcontractors performing work on-site shall also provide their standard insurance coverages in accordance with industry standards which meet or exceed minimum state requirements. Fabricon will indemnify Customer against loss, cost, expense and liability to the extent that the cause or causes of such loss, cost, expense or liability results from the proven negligence or willful misconduct of Fabricon.
8. Both Customer and Fabricon shall maintain adequate insurance for liability, including workers compensation, and property for their respective portions during completion the project. Special endorsements to Fabricon's standard certificate may be provided for an additional cost.
9. Delivery of the building modules and equipment to Customer's site is subject to delays in manufacture and delivery due to fire, flood, windstorm, riot, civil disobedience, strike, failure to secure materials from the usual source of supply, Act of God, or any other circumstances beyond the control of Fabricon.
10. Fabricon will provide shop drawings prior to fabrication of any modular building or equipment. All changes proposed by the Customer shall be made to the shop drawings. The shop drawings will be submitted to a state approved third-party agency for appropriate review and approval. The Customer will be notified if the building layout, specifications, and/or pricing requires equitable adjustment due to code or other regulatory compliance.
11. All proposed Fabricon labor shall be non-union and non-prevailing wage rates. All work priced as first shift Monday through Friday.
12. All sales and use taxes, bonds, and title fees are excluded.
13. Fabricon may subcontract through its normal insured vendor pool.
14. All changes in the work, whether requested by Fabricon or directed by Customer, shall be authorized only by written Change Order prior to commencement of the work.
15. Full payment for the modular building and all equipment shall be due no later than sixty (60) days following completion of production regardless of the status of local permits, site work, or ability to receive on-site. Fabricon may invoice modular building(s) and any equipment as stored materials at time



of completed production outside of preestablished payment terms and draw schedules if necessary due to delays in the Customer's project schedule or development when outside the control of Fabricon.

16. Fabricon shall not be held responsible for the performance of any labor or material not supplied by Fabricon including, but not limited to, warranty related items.
17. Risk of loss shall transfer to the Customer upon delivery of the building modules or equipment to Customer's site. Customer shall inspect modular building and equipment within 72 hours following Substantial Completion and Beneficial Occupancy, and provide Fabricon written notice of any defect claims or other proper objections to the modular building and/or equipment within that timeframe. Fabricon reserves the right to correct such deficiencies within a reasonable period. The Customer shall not proceed with corrections without prior written consenting approval of Fabricon.
18. New modular building and equipment Warranty is one (1) year from the date on which Fabricon memorializes Substantial Completion and Beneficial Occupancy for its work scope. Fabricon in its sole discretion and pending receipt of written notice from Customer, will repair or replace, including material and labor, any structural component of the building found to be defective and having an adverse impact on the operation and occupancy of the building. Defects or non-performance attributable to Customer's misuse, abuse, or neglect are excluded. Fabricon shall pass on all manufacturer's component warranties per their respective terms and conditions. The Customer is responsible for any manufacturer's component warranty registration. All warranties are limited to "normal" usage and exposure. The following are excluded from the definition of "normal" and therefore from this warranty: (a) failure to provide drainage of water from all surfaces on or around the building, (b) improper maintenance or neglect, (c) installation in an area subject to heavy snow, fall out of corrosive chemicals, ash or fumes from chemical plants, foundries, plating works, kilns, fertilizing manufacturers, paper plants and the like, (d) Acts of God, vandalism, falling objects, external forces, explosion, fire, riots, acts of war and radiation and (e) modifications or alterations to the building, its systems or components. The Customer shall be responsible for normal maintenance such as changing HVAC filters monthly, light bulbs, janitorial service, and minor repairs.
19. Any used/remanufactured/remodeled buildings are sold "as-is," based on availability and without warranty.
20. Fabricon will warrant the structural integrity of any modular building or equipment throughout its Lease term. However, the Customer shall be responsible for normal maintenance such as changing HVAC filters monthly, light bulbs, janitorial service, and minor repairs during the lease term.
21. The Customer warrants that it owns and/or has the legal rights to construct or place the proposed modular building and equipment on the designated property and has gained the appropriate approvals through all parties including regulatory agencies to allow the project to proceed. The Customer warrants construction will not violate zoning restrictions or other laws, and the Customer agrees to indemnify and hold Fabricon harmless from all loss, damage, and liability which may result from the proposed construction or placement of modular building(s) and equipment.
22. The Customer agrees to not interfere with the progress of the work, and to not occupy any portion of the modular building(s) or equipment until all terms and conditions herein are fulfilled by both parties. Customer further agrees to not permit workers other than those of Fabricon to work in the building or within the immediate vicinity of the building until Fabricon work is complete. The Customer agrees to pay Fabricon for any damage caused to completed work or work in progress by anyone other than workers or subcontractors of Fabricon.
23. Fabricon may, during fulfillment of orders under this contract, utilize third-party financing instruments. In such case the respective transaction shall be subject to third-party credit approval and execution of such documents, which may include assignment or evidencing third-party interest in the transaction.



Such documentation may be recorded if required by the financial institute. Additional financial documentation including, but not limited to audited financial statements, may be required by the third-party.

24. Fabricon shall only be held responsible for Agreements in which it is in direct privity between itself and the Customer. All other contractual terms and conditions between the Customer and Others, including but not limited to general contractors, professional servicers, vendors, suppliers, manufacturers, etc. are the responsibility of the Customer for coordination and execution of their respective scope of work.
25. If Customer terminates the contract prior to the fabrication of the building or equipment, the Customer shall be responsible for reimbursement of all Fabricon costs incurred +20% markup. Once the production of the building modules or equipment commences the full contract sum shall become due and payable.
26. Fabricon is a small business entity (SBE) and will use its best faith efforts to utilize other small or disadvantaged business enterprises during the course of all projects.
27. Title to the equipment and lien releases shall be furnished to the Customer within sixty (60) days from Fabricon's receipt of payment in full.
28. Fabricon is a national provider of commercial mobile and modular building solutions for the Government and/or government Contractor market. All products and services offered for sale and sold to the Government and/or Government Contractors are "Commercial Items" within the meaning of Part 12 and Subpart 2.101 of the Federal Acquisition Regulation. In addition, each Government order for our products is placed on firm fixed-price terms and, in most cases, on the basis of adequate price competition. As a result, Agreements/contracts and subcontracts between Fabricon and the Government and/or Government Contractors are not subject to the Cost Accounting Standards rules and regulations of 48 CFR Chapter 99. When competing for Government work, it is the express policy of Fabricon to claim an exemption from all Cost Accounting Standards requirements under the provisions of 48 CFR 9903.201-1(b) and to certify to the monetary exemption from the requirement to submit a Disclosure Statement under the provisions of 48CFR 9903.202-1(b).
29. Fabricon fully and explicitly denies any responsibility for liquidated, consequential, or incidental damages of any kind under any circumstance.

All proposed buildings exclude exterior fire rated assemblies unless specifically noted otherwise. If fire rated assemblies are required due to proximity to existing buildings and/or property lines alternate units may be required, and additional costs may be incurred. Any modifications from Fabricon's Master Standard Fleet Specifications for its stock fleet shall be subject to additional costs. 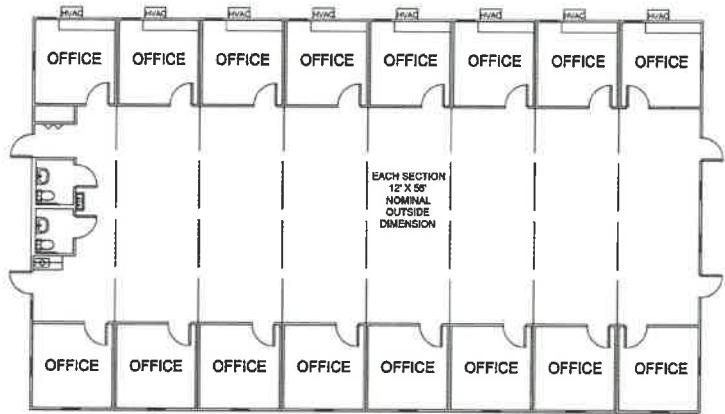


42/34 VP RAMP SYSTEM ACCESS ELEVATION VIEW
